

Your Community Bank Check Card Sweepstakes Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES.

SPONSORSHIP: Your Community Bank, a state chartered financial institution with a principal office located at 101 West Spring Street, New Albany, IN 47150, is sponsoring the Check Card Sweepstakes ("Sweepstakes").

ELIGIBILITY: To enter the Sweepstakes, you must be a lawful permanent resident of the United States, 18 years of age or older and must not be considered a minor in your state of residence. The Sweepstakes is void in Puerto Rico, U.S. territories and possessions, outside of the United States, and where restricted or prohibited by law. YOUR COMMUNITY BANK and affiliated entity (including Community Bank Shares of Indiana, Inc. and The Scott County State Bank) employees, officials, and members of their immediate families and households are not eligible to participate in the Sweepstakes.

HOW TO ENTER: The Sweepstakes begins on August 1, 2009, and ends on August 31, 2009. ("Sweepstakes Period"). There are two ways to enter: (1) by being an account holder of Your Community Bank with an active checking account and check card and use your Your Community Bank Check card for signature/credit based transaction on purchases during the promotion period or (2) by sending in a 3x5 postcard to Your Community Bank. Your Community Bank check card users who complete signature based transactions with their Your Community Bank check card will automatically be entered into the Sweepstakes. Alternatively, individuals can enter the Sweepstakes by sending in a 3x5 postcard to, "Your Community Bank Check Card Sweepstakes," 101 West Spring Street, New Albany, IN 47150, requesting to be entered into the Sweepstakes. The postcard must contain the name, address and contact information of the person requesting to participate in the Sweepstakes. Such entries must be received during the Sweepstakes Period. Proof of mailing does not constitute proof of delivery. Your Community Bank is not responsible for lost, late, incomplete, misdirected, damaged, postage due or illegible entries or mail. Once submitted, entries become the sole property of Your Community Bank and will not be acknowledged or returned. No copies or mechanical reproductions of postcards will be accepted.

DRAWING: A random drawing will be held for the qualifying signature/credit based Check Card transactions and postcards received during the Entry Period (see below) on or around August 7, 2009. Potential winners will be selected from all eligible entries received during the Entry Periods described below, by a Your Community Bank representative. In the event of uncertainty as to the identity of an entrant, the entrant will be deemed to be the primary cardholder of the applicable Your Community Bank account, or in the event there is more than one holder of such account then the primary person named on the account shall be deemed to be the entrant, or, if neither is applicable or reasonably ascertainable, the entry may be voided altogether. Odds of winning a prize depends on the number of entries received. The potential winners will be notified by phone, email or mail. If a potential winner cannot be reached within thirty (30) days from the first notification attempt, then such person shall be disqualified and an alternate winner will be selected.

Entry Period: August 1-31, 2009 Approx. Drawing Date: September 10, 2009

PRIZE: One (1) winner will be awarded a 19" Vizio LCD HDTV during the drawing period. Your Community Bank will report all prize winnings to the appropriate state and federal agencies, as required by applicable law. Winners are responsible for all tax consequences (if any) of the prizes. Winners acknowledge this responsibility by entering the sweepstakes.

PRIZE CONDITIONS: In the event a Your Community Bank representative determines, in its sole discretion based on his/her interpretation of these Official Rules, that an entrant is found to be ineligible, or if he/she does not comply with these Official Rules, then the potential winner will be disqualified and an alternate winner will be selected through a random drawing from the remaining entries. If the prize or prize notification is returned as undeliverable, this will result in disqualification, and an alternate winner will be selected. Except where prohibited by law, the winner's entry and acceptance of the prize constitutes permission for Your Community Bank to use said winner's name in all forms of media, in perpetuity, without further compensation. Further, winner must sign and return to Your Community Bank a declaration of eligibility and liability publicity release. Your Community Bank is not responsible for any incorrect or inaccurate information, whether caused by tampering, hacking, or by any of the equipment or programming associated with the Sweepstakes. Prizes cannot be substituted, assigned, or transferred by winners. Your Community Bank reserves the right to disqualify entrants who fail to follow these Official Rules and regulations or who make any misrepresentations relative to the Sweepstakes and redemption of a prize.

NO LIABILITY: By entering, winner agrees to comply with all Official Rules, as stated and agrees to release, discharge, indemnify, defend and hold harmless Your Community Bank and each of its respective officers, directors, employees, representatives and agents from and against any claims made by winners, entrants, or any other third parties, related in any way to the operation of this Sweepstakes as well as any other claims, damages or liability, injuries, damages or losses to any person (including death) or property of any kind resulting in whole or in part, directly or indirectly, from acceptance, possession, misuse or use of any prize or participation in any Sweepstakes related activity or participation in this Sweepstakes.
